- FROM THE DIRECTOR -

Growth of Manufacturing in Lexington County


A strong manufacturing base, heavily involved in a number of the sectors that have fared particularly well during the pandemic, continues to pump optimism and jobs through the Lexington County economy as 2021 rolls forward in an atmosphere of national recovery.

Those industries include pharmaceuticals (such as Nephron Pharmaceuticals), automotive (including Michelin), and food & beverage. In fact, Lexington County is part of the Central SC Region, which is home to more than 45 food processing facilities, which includes global and national brands such as Starbucks, Kraft Heinz, Pepsi and Domino's.

From a broader perspective, I want to put some additional context to the above statistics from two new reports, the first from an economist with the Darla Moore School of Business at the University of South Carolina and the second from the S.C. Department of Employment & Workforce (DEW).

A UofSC report released earlier this month says that manufacturing led the Palmetto State out of the Great Recession of 2008 and continues to play a more "uniquely dominant" role in our economy than is typical among the 50 states. In fact, manufacturing supports directly or indirectly more than 30% of all jobs in our state and pays an average salary 33% higher than the state's average wage.

The second is from an April 16 "community profile" released by DEW that shows Lexington County's unemployment rate continuing to be lower than the state and national averages for more than a decade. (For March 2021, the County was 3.7%, 4.8% for the state, and 6.2% nationally).

A diverse array of existing manufacturers in essential industries and a robust pipeline of qualified workers coming through our nationally known technical college system, as well as our colleges and universities, promises to keep Lexington County an ideal location for innovation and progress in the years ahead. Saxe Gotha Industrial Park – Lot 3



Lot 3 in Saxe Gotha Industrial Park (featured above), between Amazon and Nephron Pharmaceuticals, is a 100-acre site in total with 68 developable acres. The County is currently installing the basins, along with clearing, grubbing and grading the balance of the developable area. This site boasts:


Top 3 Labor Market Projections
